## SOCIAL INSURANCE ACT. (Cap. 145).

## SOCIAL INSURANCE (BENEFIT) (AMENDMENT) REGULATIONS 1985

In exercise of the powers conferred on him by Section 21 of the Social Insurance Act, and of all other enabling powers, the Governor has made the following regulations:

#### Title and commencement

- 1.(1) These regulations may be cited as the Social Insurance (Benefit) (Amendment) Regulations, 1985.
- (2) These regulations shall come into operation on the 24th day of December, 1985.
