## SOCIAL SECURITY (INSURANCE) ACT.

#### SOCIAL INSURANCE (BENEFITS) (AMENDMENT) REGULATIONS, 1986.

In exercise of the powers conferred on him by Section 21 of the Social Security (Insurance) Act, and of all other enabling powers, the Governor has made the following regulations:

#### Title and commencement.

1.(1) These regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 1986.

(2) These regulations shall come into operation on the 23rd day of December, 1986.

#### Amendment of Schedule 3.

2. Schedule 3 to the Social Insurance (Benefits) Regulations (hereinafter called the principal regulations) is amended by revoking Part V, and substituting the following Part:
