# SOCIAL SECURITY (CLOSED LONG-TERM BENEFITS AND SCHEME) (AMENDMENT OF BENEFITS) REGULATIONS 2017

In exercise of the powers conferred on him by Section 38 of the Social Security (Closed Long-Term Benefits and Scheme) Act 1996, and all other enabling powers, the Minister has made the following Regulations–

#### Title and commencement.

1. These Regulations may be cited as the Social Security (Closed Long-Term Benefits and Scheme) (Amendment of Benefits) Regulations 2017 and shall be deemed to have come into operation on 1 August 2017.

### Amendment of the Social Security (Closed Long-Term Benefits and Scheme) Act 1996.

2.(1) The Social Security (Closed Long-Term Benefits and Scheme) Act 1996 is amended in accordance with the provisions of this regulation.

(2) Section 16(a) is amended by substituting "£220.31" with "£226.26".

(3) Schedule 1 is amended by substituting the following Part for Part 1–
