**SOCIAL SECURITY (OPEN LONG-TERM BENEFITS SCHEME)  
ACT 1997**

**SOCIAL SECURITY (OPEN LONG-TERM BENEFITS SCHEME)  
(AMENDMENT OF BENEFITS) ORDER 2015**

In exercise of the powers conferred on him by section 46 of the Social Security (Open Long-Term Benefits Scheme) Act 1997, and all other enabling powers, and with the prior approval by resolution of the Gibraltar Parliament, the Minister has made the following Order—

**Title and commencement.**

1. This Order may be cited as the Social Security (Open Long-Term Benefits Scheme) (Amendment of Benefits) Order 2015 and shall be deemed to have come into operation on 1 August 2014.

**Amendment of the Social Security (Open Long-Term Benefits Scheme) Act 1997.**

2.(1) The Social Security (Open Long-Term Benefits Scheme) Act 1997 is amended in accordance with the provisions of this paragraph.

(2) Section 22(a) is amended by substituting “£215.98” for “£212.58”.

(3) Schedule 2 is amended by substituting the following Part for Part 1—

**“PART I**

Section 11(2)

(b) in any other case.	£431.87	£215.98	£62.41

\* Except in the case of a Widowed Parent’s Allowance where there is no limit to the number of children in respect of whom increases may be paid.”
