# SOCIAL SECURITY (OPEN LONG-TERM BENEFITS SCHEME) (AMENDMENT OF BENEFITS) (2022) ORDER 2023

In exercise of the powers conferred on him by section 46 of the Social Security (Open Long-Term Benefits Scheme) Act 1997, and all other enabling powers, and with the prior approval by resolution of the Gibraltar Parliament, the Minister has made the following Order—

#### Title and commencement.

1. This Order may be cited as the Social Security (Open Long-Term Benefits Scheme) (Amendment of Benefits) (2022) Order 2023 and shall be deemed to have come into operation on 1 August 2022.

#### Amendment of the Social Security (Open Long-Term Benefits Scheme) Act 1997.

- 2.(1) The Social Security (Open Long-Term Benefits Scheme) Act 1997 is amended in accordance with the provisions of this paragraph.
- (2) In Section 22(a) for "£241.85" substitute "£260.25".
- (3) In Schedule 2 for Part 1 substitute—
