**SOCIAL SECURITY (OPEN LONG-TERM BENEFITS SCHEME)

**SOCIAL SECURITY (OPEN LONG-TERM BENEFITS)
(AMENDMENT) REGULATIONS 2012**

In exercise of the powers conferred on him by section 23 of the Social Security (Open Long-Term Benefits Scheme) Act, 1997, and all other enabling powers, the Minister has made the following regulations-

Title and commencement.

1. These regulations may be cited as the Social Security (Open Long-Term Benefits) (Amendment) Regulations, 2012 and shall be deemed to have come into operation on 1 August, 2012.

Amendment of Schedule 1.

2. Schedule 1 of the Social Security (Open Long-Term Benefits) Regulations, 1997 (“the principal regulations”) is amended by revoking Part V and Part VI, and substituting the following Parts-
