**Citation.**

1. These regulations may be cited as the Leisure Areas (Licensing) (No.2) Regulations, 2001.

**Grant and conditions of licences.**

2. Licences under the principal Act shall be issued in the appropriate form set out in Schedule 2 for a period not exceeding twelve months on such terms and conditions and subject to such restrictions as the licensing authority thinks fit.

**Renewals.**

3. Licences issued under these Regulations may be renewed at the discretion of the licensing authority for a further period or further periods not exceeding twelve months each.

**Fees.**

4. The fees payable on the grant or renewal of a licence under these Regulations are those set out in Schedule 1.
