Title.

1. This Order may be cited as the Statistics (Employment Survey) Order.

Survey of employment.

2.(1) The Government Statistician is hereby directed to collect statistics relating to a survey of the employment, hours of work and earnings of persons employed in the undertakings specified in Schedule 1.

(2) The statistics referred to in sub-paragraph (1) shall be collected by means of returns to be made by all employers in the undertakings specified in Schedule 1 at six-monthly intervals:

Provided that if the Government Statistician is at any time of the opinion that for any reason returns made at six-monthly intervals may render such returns misleading or of doubtful value he may, with the consent of the Governor, collect returns at such other intervals as he may consider appropriate:

Provided further that no returns shall be collected at intervals of less than six months and, where any returns have been collected at more than six-monthly intervals, then in the report in respect of such returns presented to the Parliament in accordance with paragraph 3 the fact and reason therefor shall be stated in such report.

(3) The returns to be made under sub-paragraph (2) shall specify the particulars set out in Schedule 2.

Report of proceedings.

3. The Government Statistician shall, as soon as may be practicable after the expiry of six months from the date of this Order and after the expiry of every period of six months hereafter, or of such other period as may be allowed by the proviso to paragraph 2(2), prepare a report of the proceedings in connection with the collection of statistics under this Order, together with a summary of the statistics so obtained, in respect of the period of such report and such and summary shall thereupon be presented to the House of Assembly.
