#### STATISTICS ACT

# STATISTICS (EMPLOYMENT SURVEY) (AMENDMENT) ORDER 1998

In exercise of the powers conferred on him by section 5 of the Statistics Act and section 24 of the Interpretation and General Clauses Act, and of all other enabling powers and with the approval of the House of Assembly, the Governor has made the following Order -

#### Title and commencement.

- 1.(1) This Order which amends the Statistics (Employment Survey) Order (hereinafter referred to as "the principal Order") may be cited as the Statistics (Employment Survey) (Amendment) Order 1998 and, except in respect of paragraph 5 shall be deemed to have come into operation on the 1st October, 1998.
- (2) Paragraph 5 shall be deemed to have come into operation on the 16th March, 1977.

### Amendment of paragraph 2 of the principal Order.

2. In paragraph 2(1) of the principal Order (survey of employment) for the word "employment" there shall be substituted "employment, hours of work".

# Amendment of paragraph 3 of the principal Order.

3. In paragraph 3 of the principal Order (report of proceedings) the words "April and" shall be deleted.

#### Substitution of Schedule 2 of the principal Order.

4. For Schedule 2 of the principal Order (returns to be made under paragraph 2(2)), there shall be substituted the Schedule to this Order.

Amendment of paragraph 4 of the Statistics (Employment Survey) (Amendment) Order 1977.

5. In paragraph 4 of the Statistics (Employment Survey) (Amendment) Order, 1977 for the words "paragraph 1" there shall be substituted "paragraph 3".

# EXPLANATORY MEMORANDUM

This Order amends the Statistics (Employment Survey) Order of 1971 by requiring that in the statistics to be collected by the Government Statistician the number of hours of work completed by both weekly and monthly paid employees shall be recorded as well as the age of the employees.

The Order also modifies the requirement that the Government Statistician shall prepare an annual report in connection with the collection of statistics as at October in each year.

The Order further modifies retrospectively an error in paragraph 4 of the Statistics (Employment Survey) (Amendment) Order, 1977 by substituting the words "paragraph 3" for the reference "paragraph 1".

Pursuant to section 5(2) of the Statistics Act a draft of this Order was laid before the House of Assembly and approved by Resolution of the Assembly on 3rd December, 1998.
