# AN ACT TO APPROPRIATE FURTHER SUMS OF MONEY TO THE SERVICE OF THE YEAR ENDING ON THE 31<sup>ST</sup> DAY OF MARCH 2010.

## Title.

1. This Act may be cited as the Supplementary Appropriation (2009/2010) Act 2010 and comes into operation on the day of publication.

#### Consolidated Fund appropriation of recurrent expenditure 2009/2010.

2.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the year ending  $31^{st}$  March 2010, a further sum not exceeding £2,800,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 1 of the Schedule to this Act.

#### Consolidated Fund appropriation of exceptional expenditure 2009/2010.

3.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the year ending  $31^{st}$  March 2010, a further sum not exceeding £772,000.

(2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 2 of the Schedule to this Act.
