#### **TOBACCO ACT, 1997**

## TOBACCO LICENSING (FORMS, FEES, ETC.) (AMENDMENT) REGULATIONS 2022

In exercise of the powers conferred upon him by section 24 of the Tobacco Act, 1997 the Chief Minister has made the following Regulations—

#### Title.

1. These Regulations may be cited as the Tobacco Licensing (Forms, Fees, Etc.) (Amendment) Regulations 2022.

#### Commencement.

2. These Regulations come into operation on the day of publication.

### Amendment of the Tobacco Licensing (Forms, Fees, Etc.) Regulations 1997.

- 3.(1) The Tobacco Licensing (Forms, Fees, Etc.) Regulations 1997 are amended in accordance with this regulation.
  - (2) For regulation 7 substitute—

#### "Fees.

- 7.(1) The fees payable to the Government on an application for a wholesale or retail licence shall be—
  - (a) an application by a members club for a retail licence - £108
  - (b) any other application for a retail licence for single premises £5400

supplement for each additional premises to which the licence relates - £5400

(c) an application for a wholesale licence for single premises - £21,600

supplement for each additional premises
