# TOBACCO LICENSING (FORMS, FEES, ETC.) (AMENDMENT) REGULATIONS 2024

In exercise of the powers conferred upon him by section 24 of the Tobacco Act, 1997 the Chief Minister has made the following Regulations—

#### Title.

1. These Regulations may be cited as the Tobacco Licensing (Forms, Fees, Etc.) (Amendment) Regulations 2024.

#### Commencement.

2. These Regulations come into operation on 1 August 2024.

## Amendment of the Tobacco Licensing (Forms, Fees, Etc.) Regulations 1997.

- 3.(1) The Tobacco Licensing (Forms, Fees, Etc.) Regulations 1997 are amended in accordance with this regulation.
- (2) For regulation 7 substitute–

#### "Fees.

7.(1) The fees payable to the Government on an application for a wholesale or retail licence shall be—

(a)	an application by a members club for a retail licence	-	£117.50

### **EXPLANATORY MEMORANDUM**

These Regulations amend the fees in the Tobacco Licensing (Forms, Fees, Etc.) Regulations 1997 in line with the measures announced by the Chief Minister in his budget address in 2024.
