In exercise of his powers under sections 11A and 11B of the Tobacco Act 1997, the Chief Minister has made the following Notice—

#### Title and commencement.

1. This Notice may be cited as Notice of Declaration of Special Zones 2014 and comes into operation on the day of publication.

#### Notice.

- 2. The Chief Minister has-
  - (a) declared that the parts of Gibraltar demarcated in the Schedule below shaded and delineated, and cross-hatched and delineated in red shall be Special Zones for the purposes of the Tobacco Act 1997;
  - (b) prescribed that a reference to a "commercial quantity" in relation to cigarettes for the purposes of a Special Zone demarcated in the Schedule below shaded and delineated in red means 600 or more cigarettes;
  - (c) prescribed that a reference to a "commercial quantity" in relation to cigarettes for the purposes of a Special Zone demarcated in the Schedule below cross-hatched and delineated in red means over 200 cigarettes;

(d) prescribed that a reference to a "commercial quantity" in relation to cigarettes for the purposes of residents living within a Special Zone demarcated in the Schedule below shall be 2,000 or more cigarettes.

#### Revocation.

- 3. The following Notices are revoked-
  - (a) Notice of Declaration of Special Zones Etc.;
  - (b) Notice of Declaration of Special Zones Etc. No. 2 of 2012; and
  - (c) Notice of Declaration of Special Zones (Watergardens Etc.) 2014.

#### Saving and transitional provisions.

4. Paragraph 3 shall not apply in respect of any proceedings which have been instituted prior to the coming into operation of this Notice and such proceedings (including any appeals) shall continue as though this Notice had not come into operation.






