NOTICE OF CORRIGENDA

The Government of Gibraltar has issued the following corrigenda-

BROADBAND INFRASTRUCTURE REGULATIONS 2015

1. In Legal Notice No 241 of Gazette No. 4227 of 24 December 2015 make the following amendments-

- (a) in the definition of “single information point” at regulation 3 for “regulation 10” substitute “regulation 11”;
- (b) after the section heading “Access to existing infrastructure” renumber regulation 3 as regulation 4 and accordingly renumber all the regulations from that point until and including regulation 11;
- (c) in regulation 4(1) for “regulation 3(2)” substitute “regulation 4(2)”;
- (d) in regulation 6–
 - (i) in subregulation (1) for “regulation 5” substitute “regulation 6”;
 - (ii) in subregulation (2) for “regulation 4(3)” substitute “regulation 5(3)”;
- (e) in regulation 10–
 - (i) for “regulation 4” substitute “regulation 5” on each occasion that it appears;
 - (ii) in subregulation (6) for “subparagraph” substitute “subregulation”.

- (b) in regulation 107(c) for “subregulation (3)(a)” substitute “regulation 3(1)(a)”.
