**TRAFFIC ORDINANCE**

**TRAFFIC (LICENSING AND REGISTRATION)  
(AMENDMENT) REGULATIONS 2005**

In the exercise of the powers conferred upon him by sections 6, 15-20, 44, 47, 83 and 104 of the Traffic Ordinance, and all other enabling powers, the Governor has made the following Regulations—

**Title and commencement.**

1. These Regulations may be cited as the Traffic (Licensing and Registration) (Amendment) Regulations 2005 and come into operation on 1 April 2005.

**Amendment of regulations.**

2.(1) The Traffic (Licensing and Registration) Regulations are amended in accordance with this regulation.

(2) In regulation 51—

- (a) for “£2” substitute “£24”; and
- (b) in the proviso, for “£1” substitute “£2”.

(3) in Schedule 2—

- (a) in “PART 1 – MOTORCYLES”, for—

“(a) does not exceed 50cc	£10.00
(b) exceeds 50cc but does not exceed 150cc	£30.00
(c) exceeds 250cc	£40.00”

substitute

- “(a) does not exceed 125 cc
- £15.00

- (b) exceeds 125 cc but does not exceed 250 cc      £35.00
- (c) exceeds 250 cc      £45.00”;

- (b) in “SECTION II - PRIVATE MOTOR VEHICLES OTHER THAN VEHICLES SPECIFIED IN PARTS I AND V”, for–

“Weight of vehicle unladen–

Not exceeding 10cwts	£45.00
Exceeding 10 cwts. but not exceeding 10 cwts	£50.00
Exceeding 10 cwts. but not exceeding 20cwts	£55.00

- (i) in column 1 for “12 cwts” and “16 cwts” substitute “610 kilograms” and “812 kilograms”;

- (ii) in column 2 for “12 cwts” and “16 cwts” substitute “610 kilograms” and “812 kilograms”;
  - (iii) in columns 1 and 2 wherever “ton” or “tons” appears substitute “tonne” or “tonnes”;
  - (iv) in column 4 in both places “5 cwts” appears substitute “254 kilograms”;
- (d) after “SECTION III – MOTOR TRACTORS AND GOODS VEHICLES OTHER THAN VEHICLES SPECIFIED IN PARTS I AND V”, insert the following Part–
