TRAFFIC ORDINANCE

TRAFFIC (LICENSING AND REGISTRATION) (AMENDMENT No.2) REGULATIONS 2005

In the exercise of the powers conferred upon it by sections 57, 61, 80, 89 and 101 of the Traffic Ordinance and all other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Traffic (Licensing and Registration) (Amendment No.2) Regulations 2005.

Amendment of Traffic (Licensing and Registration) Regulations.

- 2.(1) The Traffic (Licensing and Registration) Regulations are amended in accordance with the provisions of this regulation.
- (2) For the heading of Part III, for "Self-drive operator's licences" substitute "Self-drive car licences".
- (3) Regulations 47, 48 and 49 are revoked.
- (4) Regulations 53, 54 and 55 are revoked.
- (5) In regulation 70A for "Schedule 4A" substitute "Schedule 4B".
- (6) In regulation 71(2)(b) for "taxi" substitute "motor vehicle within category B as a public service vehicle".
- (7) In regulation 73–
 - (a) for subregulation (2) substitute-
 - "(2) Except where an applicant is licensed in respect of category B+E an applicant for a driving licence or a learner's licence to

drive vehicles in any of categories C to J shall not be issued with such licence unless he produces to the licensing authority a certificate issued by a medical practitioner registered in Gibraltar certifying that he has, not earlier than six months before the date of his application, been examined and found medically fit to drive."; and

- (b) in subregulation (3) for "Traffic Commission" substitute "licensing authority".
- (8) In regulation 75-
 - (a) for the heading "Periodical examination of drivers of category C, C1 and E to K vehicles." substitute "Periodical examination of drivers of category C to J vehicles, except category B+E."; and
 - (b) for subregulation (1) substitute "(1) Except for the holder of a category B+E driving licence, the holder of a driving licence who is authorised to drive vehicles in any of categories C to J shall from time to time such that not more than five years shall elapse between one such examination and the other, submit himself for examination by a medical practitioner registered in Gibraltar."
- (9) Regulation 76 is revoked.
- (10) In Regulation 78 for "number 19 in Schedule 1" substitute "prescribed by the licensing authority".
- (11) Regulations 88 to 92 are revoked.
- (12) For regulation 93 substitute-

"Forms.

- 93. "Form 23 shall be used in the case to which it refers.".
- (13) In regulation 95(1) after "Schedule" insert "6".
- (14) In Schedule 1 forms 15, 16 and 24 are revoked.

(15) In section 7 of Schedule 2 Parts II, III, IV and VI are revoked.
