TRAFFIC ACT 2005

TRAFFIC (LICENSING AND REGISTRATION) (AMENDMENT) (No.2) REGULATIONS 2014

In exercise of the powers conferred on it by section 80 of the Traffic Act 2005, and all other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Traffic (Licensing and Registration)(Amendment) (No.2) Regulations 2014.

Amendment of the Traffic (Licensing and Registration) Regulations.

- 2. The Traffic (Licensing and Registration) Regulations are amended as follows-
 - (a) in regulation 2, after the definition of "Compulsory Basic Training Course" insert—

""classic motor vehicle" means a motor vehicle which was first registered, whether in Gibraltar or any other country, over 25 years from the date of the first application for registration under these Regulations;"

- (b) for regulation 3(3) substitute-
 - "(3) A motor vehicle licence shall in respect of a classic motor vehicle, not be issued unless in addition to satisfying the provisions of sub-regulation (1)(a), the applicant produces—
 - (a) evidence that the motor vehicle is insured in accordance with the requirements of the

Insurance (Motor Vehicles) (Third Party Risk) Act, 1986; and

- (b) either-
 - (i) a valid roadworthiness certificate issued under the Motor Vehicles Test Regulations 1987; or
 - (ii) in respect of a classic motor vehicle manufactured before 1 January 1960 evidence that the classic motor vehicle was manufactured before 1 January 1960 and a valid roadworthiness classic certificate or a valid roadworthiness certificate issued under the Motor Vehicles Test Regulations 1987.
- (4) Motor vehicle licences shall be in such form as may, from time to time, be required by the licensing authority and an annual fee for the motor vehicle licence shall be charged in accordance with the annual fees set out in Schedule 2.";
- (c) in regulation 4(b) after "roadworthiness certificate" insert "or roadworthiness classic certificate";
- (d) after regulation 16A insert-

"Exhibition of registration marks - classic motor vehicles.

- 16AA.(1) In relation to classic motor vehicles, regulations 16 and 16A are subject to this regulation.
- (2) Regulation 16A shall apply to a classic motor vehicle which was first registered, whether in Gibraltar or elsewhere, after the 6 September 2001.
- (3) In respect of a classic motor vehicle which was first registered, whether in Gibraltar or elsewhere, before the 6 September 2001–

- (a) save where paragraph (b) applies, regulation 16A shall apply to that classic motor vehicle;
- (b) regulation 16 shall apply in relation to that classic motor vehicle where requested, in writing, by the owner of the classic motor vehicle."; and
- (e) in Schedule 2 "Part V.-SPECIAL CLASSES OF VEHICLES" after paragraph "8." insert—

EXPLANATORY MEMORANDUM

These regulations amend the Traffic (Licensing and Registration) Regulations in order to—

- o change the fee to be paid in respect of vehicle licences in respect of classic motor vehicles to nil; and
- enable owners of classic motor vehicles to choose to have an old style registration mark (as set out in Schedule 3 and required by regulation 16) rather than the more modern registration mark (as set out in Schedule 3A and required by regulation 16A).
