**TRAFFIC ACT 2005**

**TRAFFIC (LICENSING AND REGISTRATION) (AMENDMENT)  
REGULATIONS 2016**

In exercise of the powers conferred upon it by sections 7, 12, 57, 61, 80, 89 and 101 of the Traffic Act 2005, and all other enabling powers, the Government has made the following Regulations–

**Title and commencement.**

1. These Regulations may be cited as the Traffic (Licensing and Registration) (Amendment) Regulations 2016 and come into operation on 1 May 2016.

**Amendment to Traffic (Licensing and Registration) Regulations.**

2. The Traffic (Licensing and Registration) Regulations are amended in accordance with the provisions of these Regulations.

**Amendment to Regulation 33.**

3. In subregulation 33(b) substitute “5” for “10”.

**Amendment to Schedule 2.**

4. In Section 7 titled “REGISTRATION, CERTIFICATE OF REGISTRATION AND TRANSFER OF OWNERSHIP”–

- (a) in paragraph 1 substitute “£15.00” with “£20.00”;
- (b) in paragraph 3 substitute “£15.00” with “£20.00”
- (c) in paragraph 4 substitute “£15.00” with “£20.00”;
- (d) in paragraph 5 substitute “£15.00” with “£20.00”.

5. In Part V titled “DRIVING LICENCES” –

- (a) in paragraph 1 substitute “£25.00” with “£35.00” and in the proviso substitute “£2.00” with “£3.00”;
- (b) in paragraph 2 substitute “£25.00” with “£35.00” and in the proviso substitute “£2.00” with “£3.00”;
- (c) in paragraph 9 substitute “£25.00” with “£35.00”.

6. In Part VII titled “DRIVING TESTS” –

- (a) in Category “A” substitute “£30.00” with “£40.00”;
- (b) in Category “B” substitute “£30.00” with “£40.00”;
- (c) in Category “B+E” substitute “£50.00” with “£60.00”;
- (d) in Category “F to J” substitute “£50.00” with “£60.00”;
- (e) in “Public service vehicle up to 8 seats in addition to the driver’s seat” substitute “£50.00” with “£60.00”;
- (f) in “Theory “A” Category” substitute “£10.00” with “£15.00”;
- (g) in “Theory “B” Category” substitute “£10.00” with “£15.00”.

7. After the last entry appearing under “PART VII – DRIVING TESTS” insert the following—

**“Annual indexation of fees.**

- 1. Subject to the provisions of this regulation, the fees set out in the tables below (using the same paragraph numbering as appearing in Schedule 2) must be revised annually in accordance with the Index of Retail Prices published by the Government Statistician.
- 2. The first revision under this regulation shall apply as from the 1 May 2017 and shall apply the index of retail prices as at the 1 January 2017, and subsequent revisions shall apply on each subsequent 1 May and apply the index of retail prices prevailing on the preceding 1 January of that year.

3. Any figure revised pursuant to subregulation (1) shall be rounded up to the next whole penny.
