TRAFFIC ACT 2005

TRAFFIC (LICENSING AND REGISTRATION) (AMENDMENT) REGULATIONS 2021

In the exercise of the powers conferred on it by section 101 of the Traffic Act 2005, and any other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Traffic (Licensing and Registration) (Amendment) Regulations 2021 and come into operation on the day of publication.

Amendments to the Traffic (Licensing and Registration) Regulations.

- 2.(1) The Traffic (Licensing and Registration) Regulations are amended in accordance with this regulation.
 - (2) In regulation 6, delete subregulation (2).
 - (3) In regulation 7, in subregulation (2), for "fee", substitute "fees".
- (4) In regulation 8, in subregulation (2), after "sub-regulation (1)" insert "together with the prescribed fee".
- (5) In regulation 9, after "certificate of registration for amendment" insert "together with the prescribed fee".
 - (6) In regulation 14, in subregulation (1), for "a fee of £5" substitute "the prescribed fees".
 - (7) In regulation 33–
 - (a) in paragraph (a), for "£5" substitute "£15"; and
 - (b) in paragraph (b), for "10 pence" substitute "£15".
 - (8) In Schedule 2, substitute the following for the entirety of "SECTION 7."-

- 1. Subject to the provisions of this regulation, the fees set out in the tables below (using the same paragraph numbering as appearing in Schedule 2) must be revised annually in accordance with the Index of Retail Prices published by the Government Statistician.
- 2. The first revision under this regulation shall apply as from the 1 May 2022 and shall apply the index of retail prices as at the 1 January 2022, and subsequent revisions shall apply on each subsequent 1 May and apply the index of retail prices prevailing on the preceding 1 January of that year.
- 3. Any figure revised pursuant to subregulation (1) shall be rounded up to the next whole penny.
