TRAFFIC ACT 2005

TRAFFIC (LICENSING AND REGISTRATION) (AMENDMENT) REGULATIONS 2022

In the exercise of the powers conferred on it by section 101 of the Traffic Act 2005, and any other enabling powers, the Government has made the following Regulations–

Title.

1. These Regulations may be cited as the Traffic (Licensing and Registration) (Amendment) Regulations 2022 and come into operation on the day of publication.

Amendments to the Traffic (Licensing and Registration) Regulations.

2.(1) The Traffic (Licensing and Registration) Regulations are amended in accordance with this regulation.

(2) In Schedule 2, substitute the following for the entirety of "SECTION 7."-

2. The first revision under this regulation shall apply as from the 1 May 2022 and shall apply the index of retail prices as at the 1 January 2022, and subsequent revisions shall apply on each subsequent 1 May and apply the index of retail prices prevailing on the preceding 1 January of that year.

3. Any figure revised pursuant to subregulation (1) shall be rounded up to the next whole pound.
