TRAFFIC ACT 2005

TRAFFIC (LICENSING AND REGISTRATION) (AMENDMENT) REGULATIONS 2024

In exercise of the powers conferred upon the Government under section 15(2), 57 and 101 of the Traffic Act 2005, and all other enabling powers, the Government has made the following Regulations-

Title.

1. These Regulations may be cited as the Licensing and Registration (Amendment) Regulations 2024.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendments to the Traffic (Licensing and Registration) Regulations.

- 3.(1) The Traffic (Licensing and Registration) Regulations are amended in accordance with this regulation.
- (2) In regulation 2, insert the following definition after the definition of "pedestrian controlled vehicle"-
 - ""registered keeper" in relation to a vehicle, means the person by whom the vehicle is kept and used if the person is different to the owner";
- (3) In regulation 2, in the definition of "visitors registration document" insert "and registered keeper, if applicable" after "owner".
- (4) In regulation 6, insert the following subregulation after subregulation (1)-
 - "(1A) The certificate of registration shall contain particulars of the registered keeper, if applicable.
 - "(1B) An owner of a vehicle shall apply to the licensing authority to include a registered keeper in the certificate of registration."
- (5) In regulation 6, in subregulation (4), insert "or registered keeper" after "owner".

- (6) In regulation 7, in subregulation (1), insert "and registered keeper, if applicable" after "name and address of the new owner".
- (7) In regulation 7, in subregulation (2), insert "and registered keeper, if applicable" after "new owner".
- (8) In regulation 14, in subregulation (1), substitute "the owner of the vehicle or his agent shall apply" with "the owner of the vehicle, his agent or the registered keeper".
- (9) In regulation 14, in subregulation (2), insert "or the registered keeper" after "the owner of the vehicle".
- (10) In regulation 20, in subregulation (2)(c), insert "and registered keeper, if applicable" after "new owner" the first time that it appears.
- (11) In regulation 20, in subregulations (3), (4) and (5) insert "and registered keeper, if applicable" after "new owner" every time that it appears.
- (12) In regulation 21, in subregulation (2)(c), insert "and registered keeper, if applicable" after "new owners".
- (13) In regulation 21, in subregulations (3), (3A), (3B), (4)(d) and the paragraph following subregulation (7)(b) insert "and registered keeper, if applicable" after "new owner" every time that it appears.
- (14) In regulation 21A, in subregulation (2)(c), insert "and registered keeper, if applicable" after "new owner" the first time that it appears.
- (15) In schedule 1, substitute Form 4 with-
