#### TRAFFIC (PARKING AND WAITING) ORDER

#### Title.

1. This Order may be cited as the Traffic (Parking and Waiting) Order.

#### Interpretation.

- 2. In this Order, unless the context otherwise requires-
  - "private hiring car" means a public service vehicle which does not ply for hire in a public place;
  - "traffic sign" means a traffic sign as defined in section 83 of the Act;
  - "vehicle" includes animal drawn vehicles, motor vehicles, bicycles, tricycles, hand carts and all other contrivances, the primary purpose of which is the conveyance of goods or persons;
  - "waiting" means the stopping of the vehicle with the driver thereof remaining at the controls and able to drive it away immediately.

#### General Prohibition of Parking.

#### **Prohibition of parking.**

3. (1) No person shall park a vehicle at any place where parking is prohibited by any traffic sign except, in the case of goods vehicles, for such time as is reasonably necessary for the loading or unloading of merchandise.

(1A) No person shall park a vehicle upon any footpath.

(2) A person shall not be deemed to have parked a vehicle if the driver thereof remains at the controls of the vehicle and is able to drive it away immediately.

#### Saving for medical practitioners.

4. Paragraph 3 shall not apply to a medical practitioner when attending patients, provided that he is exhibiting on his windscreen a permit in the form set out in Schedule 1, or to an ambulance whilst on duty.

7. No person (other than a taxi driver in a taxi plying and ready for hire) shall park or wait in a vehicle at a taxi rank as set out in schedule 2.

10. The area demarcated in yellow paint on the north side of the City Fire Service Station at Red Sands Road shall be reserved for the parking of Official Fire Service vehicles and no person shall wait or park any vehicle in such area without the permission of the Chief Fire Officer.

# Parking space for official vehicles of the Gibraltar Health Authority and ambulances.

11. The area demarcated in yellow paint at Hospital Ramp and the South Side of Harbour Views Road by the Hospital shall be reserved for the parking of official vehicles of the Gibraltar Health Authority and ambulances and no person shall wait or park any vehicle in such area without the permission of the General Manager of the Gibraltar Health Authority.

#### Parking space for official Prison vehicles.

12. The area demarcated in yellow paint opposite the northern end of Tankerville House at Tarik Road shall be reserved for the parking of official Prison vehicles, and no person shall wait with or park any vehicle in such area without the permission of the Superintendent of the Prison.

(2) A space designated under sub-paragraph (1) on which a vehicle may park may only be used–

- (a) by such persons as may be authorised in the notice of designation;
- (b) by such vehicles as may be authorised in the notice of designation; and

subject to such conditions as the Minister may specify in the notice of designation, including but not restricted to-

- (i) the payment of fees, and
- (ii) entering into a written licence agreement with the government.
- (3) A designation under sub-paragraph (1) shall be demarcated by-
  - (a) markings on the ground delineating the borders of the space, and
  - (b) notices or traffic signs erected in proximity to the demarcation.

(4) Notices or traffic signs erected under sub-paragraph (3)(b) shall advertise the status of the area as a space on which vehicles may or may not park, as the case may be.

(5) Where the use of the parking space is subject to any condition, a notice or a traffic sign erected under sub-paragraph (3)(b) shall advertise the existence of that condition.

(6) A person responsible for any act or omission contrary to subparagraph (2) shall be guilty of an offence.

(7) The Minister may by order published in the Gazette provide that any or all of the areas to which paragraph 12B applies shall be 'residents only' parking areas.

(8) If the minister makes an order under sub-paragraph (7) he may provide (on payment of any fee and under such conditions as he thinks fit) for 'residents parking' permits to be issued in respect of vehicles belonging to or permanently under the control of residents of the areas concerned; a

person who leaves a vehicle in such an area without a resident's parking permit is guilty of an offence and the vehicle may be towed away under the Control of Traffic Regulations or immobilised under the Traffic (Immobilisation of Vehicles No. 2) Regulations 1986.

(9) Sub-paragraph (8) applies whether or not parking spaces in the area concerned have been demarcated under sub-paragraph (1).

(10) References in this paragraph and in paragraph 12B to the Minister are references to the Minister with responsibility for Transport.

#### Restriction on parking within communal areas.

12D. Where an area is designated under paragraph 12B the parking of a motor vehicle within a communal part of a building such as a foyer, patio or passage, is prohibited and a person parking within such a communal part is guilty of an offence.
