TRAFFIC ACT 2005

**TRAFFIC (LICENSING AND REGISTRATION) (PERSONALISED
NUMBERS) (AMENDMENT NO.2) REGULATIONS 2013**

In exercise of the powers conferred upon it by sections 15, 58 and 101 of the Traffic Act 2005, the Government has made the following Regulations–

Title and commencement.

1. These Regulations may be cited as the Traffic (Licensing and Registration) (Personalised Numbers) (Amendment No.2) Regulations 2013 and come into operation on the day of publication.

Amendment of regulations.

2.(1) The Traffic (Licensing and Registration) (Personalised Numbers) Regulations, 1985 are amended in accordance with the provisions of these Regulations.

(2) In regulation 3(c) for “G5010” substitute “G20000”.

(3) In regulation 5–

- (a) in subregulation (1) for the word “advertise” substitute the words “make available upon request”;
- (b) in subregulation (2) delete the words “Only those applications which are received within the period stipulated in the advertisement provided for in the preceding sub-regulation will be considered. After such period has elapsed the Licensing Authority will notify each and every unsuccessful applicant that his or her application has not been accepted.”;
- (c) in subregulation (4) after the words “fails to make” insert the word “an”; and

- (d) in subregulation (5) for the words “is £200” substitute the words “is the sum adjacent to the number series set out in the table in Schedule 1”.

(4) After regulation 7 insert–

“Excluded numbers.

8. Personalised numbers set out in Schedule 2 shall be reserved for issue to motor vehicles registered to the Government.

Registration number issued prior to these Regulations.

9. Registration numbers issued to motor vehicles which were registered prior to 16 May 1985 and which are listed in Schedule 3 shall not be personalised numbers under these Regulations unless the motor vehicle is deregistered and that number becomes available for re-issue.
