TRAFFIC ACT.

TRAFFIC (TOUR GUIDES) REGULATIONS. 1989.

In exercise of the powers conferred upon him by section 83 and 92 of the Traffic Act and of all other enabling powers the Governor has made the following regulations

Title and commencement.

I . (1) These regulations may be cited as the Traffic (Tour Guides) Regulations 1989.

(2) These regulations shall come into force on the 1st day of October, 1989.

Amendment of the Traffic (Upper Rock Restriction) (Amendment) Regulations 1986.

2. The Traffic (Upper Rock Restriction) (Amendment) Regulations 1986 are amended – $\ensuremath{\mathsf{-}}$

- (a) in regulation 2, by adding in the appropriate alphabetical position the following additional definition –
- "`tour guides authority" means the licensing authority appointed by rule 3 of the Licensing (Tour Guides) Rules 1989;';
 - (b) in regulation 4(6), by inserting at the end thereof the following words—
- 'and, in the case of a public service vehicle, is displaying a vehicle plate issued under regulation 4A(1)';
 - (c) by inserting the following additional regulation immediately after regulation 4-

"Vehicle plates.

4A. (1) The tour guides authority shall, on payment of a deposit of 15.00, issue a vehicle plate, which shall be as in Form 4 in the Second Schedule, to the owner of every public service vehicle to which an exemption certificate has been granted by the Traffic Commission under regulation 4.

(2) Every vehicle plate issued by the tour guides authority under sub-regulation (1) shall remain the property of the Government and shall be returned to the tour guides authority within seven days of the expiry or cancellation of the exemption certificate in respect of which a has been issued unless in the meantime a further exemption certificate has been granted in respect of the same vehicle.

(3) Upon the return of the vehicle plate in good condition, fair wear and tear excepted, within the said period of seven days, the tour guides authority shall return the deposit of £15.00 but not otherwise except in its discretion.

(4) Every person to whom a vehicle plate is issued under sub-regulation (1) shall cause the same to be securely affixed in a prominent position on the front of the vehicle in respect of which it is issued."; and

(d) in the Second Schedule, by inserting the following additional form after Form 3-

Amendment of the Public Service Vehicles Regulations.

3. The Public Service Vehicles Regulations are amended-

(a) by inserting the following new regulation immediately after regulation 7-

"Use of public service vehicles for tours.

7A.(1) No public service vehicle shall be used for , the purpose of a prescribed tour unless-

- (a) the tour is conducted by a tour guide;
- (b) the vehicle bears a vehicle plate in accordance with regulation 4(6) of the Traffic (Upper Rock Restriction) (Amendment) Regulations 1986; and
- (c) every passenger is in possession of a valid ticket.

(2) In this regulation the expressions "passenger", "prescribed tour", "tour guide" and "ticket" have the meanings respectively assigned to them by rule 2 of the Licensing (Tour Guides) Rules 1989."; and

(b) Part II of the Schedule is amended by omitting item 1.
