TRAFFIC ACT 2005

MOTOR VEHICLES TEST (AMENDMENT) REGULATIONS 2016

In exercise of the powers conferred upon it by sections 7, 8, 12, 80 and 101 of the Traffic Act 2005, and all other enabling powers, the Government has made the following Regulations–

Title and commencement.

1. These Regulations may be cited as the Motor Vehicles Test (Amendment) Regulations 2016 and come into operation on the 1 May 2016.

Amendment of the Motor Vehicles Test Regulations 1987.

2. The Motor Vehicles Test Regulations 1987 are amended in accordance with the provisions of these Regulations.

Amendment to Schedule 5.

- 3. In paragraph 1–
 - (a) in subparagraph (a) substitute "£20.00" with "£30.00";
 - (b) in subparagraph (b) substitute "£15.00" with "£20.00";
 - (c) in subparagraph (c) substitute "£45.00" with "£60.00";
 - (d) in subparagraph (d) substitute "£20.00" with "£30.00";
 - (e) in subparagraph (e) substitute "£40.00" with "£55.00".
- 4. In paragraph 8 substitute "£10.00" with "£20.00".
- 5. After paragraph 8 insert the following—

"Annual indexation of fees.

- 1. Subject to the provisions of this regulation, the fees set out in the table below (using the same paragraph numbering as appearing in Schedule 5) must be revised annually in accordance with the Index of Retail Prices published by the Government Statistician.
- 2. The first revision under this regulation shall apply as from the 1 May 2017 and shall apply the index of retail prices as at the 1 January 2017, and subsequent revisions shall apply on each subsequent 1 May and apply the index of retail prices prevailing on the preceding 1 January of that year.
- 3. Any figure revised pursuant to subregulation (1) shall be rounded up to the next whole penny.

(a) a private motor vehicle	30
(b) a motor cycle	20
(c) a public service vehicle with seating capacity for more than 8 passengers	60

(e) a goods vehicle the unladen weight of which exceeds 1,525 kilograms	55
8. For the issue of a duplicate roadworthiness certificate or roadworthiness classic certificate	20
