**TRAFFIC ACT 2005**

**TRAFFIC (PEDESTRIANISATION) REGULATIONS 2001**

**TRAFFIC (DESIGNATION OF PEDESTRIANISED  
AREAS) (AMENDMENT) ORDER 2018**

In exercise of the powers conferred on him by regulation 3 of the Traffic (Pedestrianisation) Regulations 2001, the Minister has made the following Order—

**Title.**

1. This Order may be cited as the Traffic (Designation of Pedestrianised Areas) (Amendment) Order 2018.

**Commencement.**

2. This Order comes into operation on 6 August 2018.

**Amendment to the Traffic (Designation of Pedestrianised Areas) Order 2001.**

3.(1) The Traffic (Designation of Pedestrianised Areas) Order 2001 is amended in accordance with this paragraph.

(2) In paragraph 2—

(a) in subparagraph (g), after “Casemates House” insert “(except for bicycles travelling from Grand Casemates Gates up to the entrance of Main Street)”;

(b) in subparagraph (h), after “No. 5 Cathedral Square” insert “(except for bicycles travelling from the junction of Main Street and George’s Lane towards Secretary’s Lane)”;

(c) in subparagraph (m), after “junction” insert “(except for bicycles travelling from Irish Town to the archway entrance to Cooperage Lane)”;

(d) for subparagraph (n) substitute the following–

“(n) George’s Lane (except for taxis and bicycles);”;

(e) in subparagraph (p), after “Cooperage Lane junction” insert “(except for bicycles travelling from John Mackintosh Square junction to Cooperage Lane junction)”;

(f) in subparagraph (q), after “5 John Mackintosh Square” insert “(except for bicycles travelling from the junction at 5 John Mackintosh Square to the junction of John Mackintosh Square and Irish Town)”;

(g) in subparagraph (u), after “Mill Lane junction” insert “(except for bicycles travelling from Casemates Square to Cathedral Square junction)”.

(3) For paragraph 3 substitute the following–

**“Vehicles.**

3. No person may drive, park or be in charge of a vehicle in a Pedestrianised Area unless it is permitted under paragraph 2 or it is being done in connection with a permit issued under regulation 6 of the Traffic (Pedestrianisation) Regulations 2011.”.

(4) After paragraph 3 insert the following–

**“Bicycles.**

4. (1) No person may ride or park a bicycle in a Pedestrianised Area unless it is permitted under paragraph 2.

(2) Notwithstanding paragraph 2, the use of bicycles in a Pedestrianised Area must conform with any traffic signs applicable to bicycles.”.
