TRAFFIC ORDINANCE

**TRAFFIC (PARKING AND WAITING ORDER AMENDMENT)
(NO2) REGULATIONS 2005**

In exercise of its powers under section 91(1) of the Traffic Ordinance, the Government has made the following regulations—

Title.

1. These regulations may be cited as the Traffic (Parking and Waiting Order Amendment) (No2) Regulations 2005, and come into operation on the day of publication save for paragraph 2(3) which comes into operation on the day appointed by the Minister by Notice in the Gazette.

Amendments to the Traffic (Parking and Waiting) Order.

2. The Traffic (Parking and Waiting) Order is amended by—

(1) inserting the following as paragraph 7—

“7. No person (other than a taxi driver in a taxi plying and ready for hire) shall park or wait in a vehicle at a taxi rank as set out in schedule 2.”;

(2) in paragraph 11, deleting “underneath the Out-patients Department” and inserting in place of the words “and the South Side of Harbour Views Road by the Hospital”;

(3) inserting the following as paragraph 12B(2)

“2. A person who parks or waits with a motorcycle in a space demarcated as a car parking space in an area designated under paragraph 12B is guilty of an offence.”;

(4) inserting after subparagraph (i) of paragraph 12B—

“(j) Alameda Housing Estate.”;

- (5) inserting a new paragraph 12D after paragraph 12C–

“Restriction on parking within communal areas.

12D Where an area is designated under paragraph 12B the parking of a motor vehicle within a communal part of a building such as a foyer, patio or passage, is prohibited and a person parking within such a communal part is guilty of an offence.”;

- (6) replacing paragraph 14 with the following–

“Parking in car parks.

14. No person shall park a vehicle in a car park other than appropriately within the area demarcated with paint on the ground.”;

- (7) deleting “yellow” in paragraph 15(5) and 15A(2);

- (8) inserting the following as paragraph 16–

“Parking in public places.

16. Where, outside a car park specified in Schedule 5, parking spaces in a public place are demarcated by paint on the ground, no person shall park a vehicle unless the vehicle and all its component parts is completely within the demarcated area.”;

- (9) inserting the following as Schedule 2

Place	Locations
Frontier	Rank on west side of Winston Churchill Avenue from junction with entrance to Four Corners MOD Estate to Customs post and continues to rank on east side of Winston Churchill Avenue from junction of British Lines Road to entrance to Airport loading sheds and demarcated by paint and traffic signs.
Casemates Hill	Rank on south side of hill and demarcated by paint and traffic signs.
Casemates Hill	Rank on north side of hill and demarcated by paint and traffic signs.
John Mackintosh Square	Rank on the south side of the square from No 11 John Mackintosh Square to the junction with Main Street and demarcated by traffic signs.
Cathedral Square	Rank on the north face of the Cathedral of the Holy Trinity and demarcated by traffic signs.

Cathedral Square	Rank one space in front of N ^o 6 Cathedral Square and demarcated by traffic signs.
Trafalgar Cemetery	Rank across the front of Cemetery and demarcated by paint and traffic signs.

(10) revoking paragraph 23;

(11) Part 1 of Schedule 5 to the Parking and Waiting Order is amended as follows—

(a) the following are added in the appropriate alphabetical place—

(i) Commonwealth Parade Car Park;

- (ii) the area bounded by the rowing clubs and the west facing elevation of Bishop Canilla House;
- (iii) South Barracks Car Park;
- (iv) Landport Car Park

as demarcated on the plans in the Schedule hereto, which is added as Part 3 of Schedule 5;

(b) the following are deleted—

- (i) British Lines Road;
- (ii) Catalan Bay Village;
- (iii) Casemates Square;
- (iv) Moorish Castle Estate;
- (v) Queensway Tennis Court;
- (vi) Winston Churchill Avenue, recess on the east side opposite Shell Petrol Station;
- (vii) Varyl Begg Estate;
- (viii) Casemates Square on the east side of the central reservation (from Part II of the Schedule).

(12) Schedule 7 to the Parking and Waiting Order is replaced by the following—

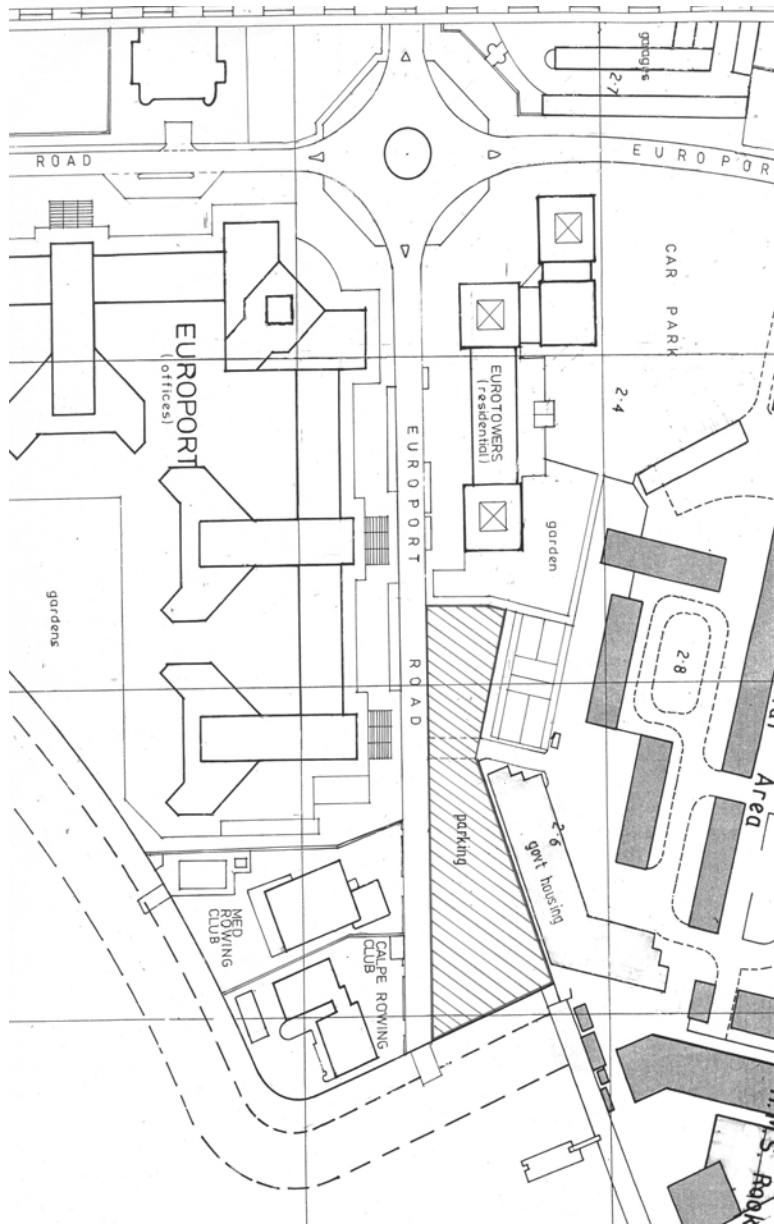

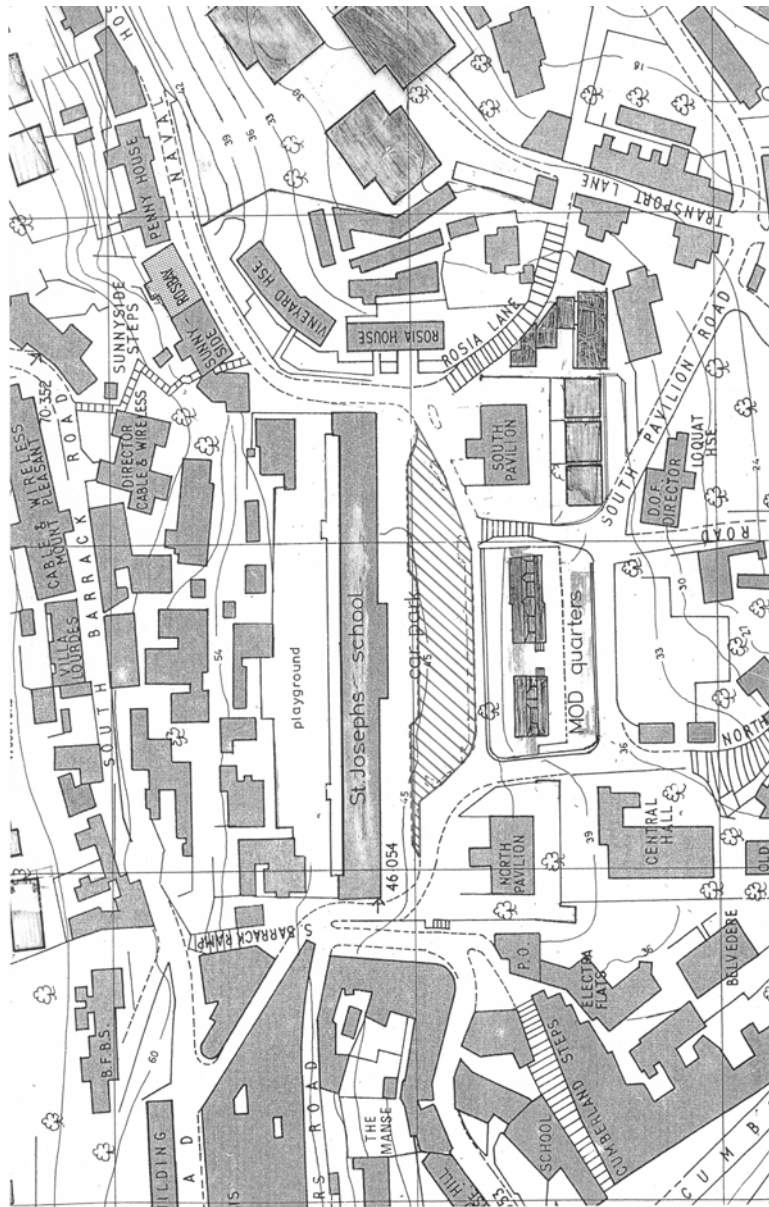

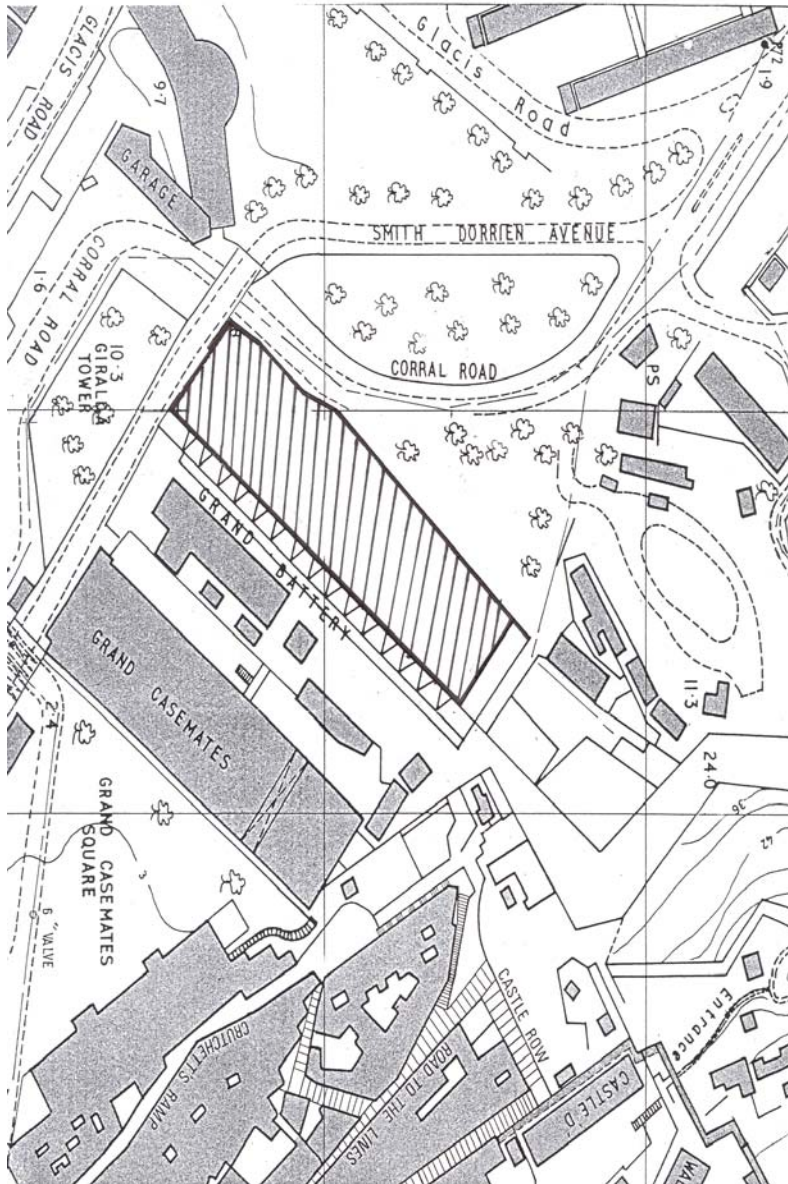

EXPLANATORY MEMORANDUM

This Order amends the Parking and Waiting Order and updates the list of public car parks and loading bays in the Order.

The Order also creates the offence of parking a motor vehicle within the communal areas of buildings which are in estates, or areas which have been designated under paragraph 12B. Alameda Estate is added to the list of designated areas.
