In exercise of the powers conferred on the Government by section 97 of the Traffic Act 2005, the Government has made the following Regulations—

Title and commencement.

1. These Regulations may be cited as the Traffic (Fixed Penalty) Regulations 2011 and come into operation on publication.

Offences.

2. The offences listed in Schedule 1 to these Regulations are declared to be offences for the purposes of section 97 of the Act and to be known as "fixed penalty offences".

Fixed penalty rates.

3. The fixed penalty for an offence described and listed in the second and third columns respectively of the table in Schedule 1 shall be that in the fourth column.

Form of notice under section 97.

- 4.(1) A notice under section 97(2) of the Act offering the opportunity of the discharge of any liability to conviction of an offence to which that section applies by payment of a fixed penalty (hereinafter in these regulations referred to as "a notice") shall be in the form in Schedule 2 or in a form to the like effect or any form that contains the information required by these regulations, the Act or any other Regulations made under the Act.
- (2) A notice, in specifying an alleged offence, shall contain a reference to the section of the Act or, as the case maybe, the rule, order or regulation allegedly contravened.

Copy to be sent to the designated person.

5. A copy of any notice given under section 97 shall, as soon as practicable, be forwarded by or on behalf of the police officer or authorised person giving the notice to the designated person.

Identification of notice.

6.(1) The person paying a fixed penalty shall either forward with the remittance the payment slip attached to the relevant notice or identify the notice by specifying its serial number.

(2) If, owing to the failure of the person paying a fixed penalty to comply with the provisions of sub-regulation (1), the designated person is unable to identify the relevant notice, the designated person shall, as soon as practicable, return the remittance to that person.

Only full amount of penalty to be accepted.

7. If less than the full amount of a fixed penalty payable on the date of payment is tendered to the designated person in payment of the fixed penalty the clerk shall, as soon as practicable, return to the sender the amount tendered.

Discounts for prompt payment.

- 8.(1) This regulation applies where a person is served a fixed penalty notice under section 97 of the Act.
- (2) Where this regulation applies, a person who makes payment within 14 days of the fixed penalty notice being issued shall only be liable to pay 50% of the amount of the fixed penalty.

Issue of receipt.

9. Subject to the foregoing provisions of these regulations the designated person shall, as soon as practicable after payment of a fixed penalty has been made to him send to the payer a receipt for the payment.

Revocation.

10. The Traffic (Fixed Penalty Offences) Notice 2005, the Traffic (Fixed Penalty) Regulations and the Traffic (Fixed Penalty Rates) Order are revoked.

If the fixed penalty is not paid within the time limit set, the offender is liable to be prosecuted.

FOREIGN VEHICLE FIXED PENALTY DEPOSIT REQUIREMENT

A vehicle not registered in Gibraltar which is committing or has committed an offence contrary to the Traffic Act 2005 will be imposed a fixed penalty deposit requirement. Payment of the appropriate amount will be immediately made to the authorised person. The person can then, within 90 days, request a hearing.

Where a hearing is not requested and proceedings are not brought in respect of the offence, the fixed penalty deposit will be used in payment of the fixed penalty.

Where a hearing is requested, the person making the request must designate a person resident or carrying on business in Gibraltar to accept service on his behalf of the summons or other legal process document in respect of the alleged offence.

If a fixed penalty deposit requirement is not paid immediately the vehicle used to commit the alleged offence may be immobilised or removed until payment (together with applicable additional removal charges) is effected or the fixed penalty deposit requirement cancelled.
