TRAFFIC ACT 2005

TRAFFIC (FIXED PENALTY) (AMENDMENT) REGULATIONS 2017

In exercise of the powers conferred upon him by section 94A and 94C of the Traffic Act 2005 the Minister has made the following Regulations.

Title.

1. These Regulations may be cited as the Traffic (Fixed Penalty) (Amendment) Regulations 2017.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendment of Regulations.

3.(1) The Traffic (Fixed Penalty) Regulations 2011 are amended in accordance with the provisions of this regulation.

- (2) Regulation 4 is revoked.
- (3) In regulation 8-
 - (a) in subregulation (1) for "section 97" substitute "Part VIIA"; and
 - (b) after subregulation (2) insert-
 - "(3) This regulation does not apply to an offence listed in Schedule 1 which is marked with the entry "*Regulation 8(2) (50% discount) does not apply.*"
- (4) Schedule 1 is amended by inserting the following-
