TRAFFIC ACT 2005

TRAFFIC (FIXED PENALTY) (AMENDMENT) REGULATIONS 2023

In exercise of the powers conferred upon it by sections 94A and 94C of the Traffic Act 2005 and all other enabling powers, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Traffic (Fixed Penalty) (Amendment) Regulations 2023.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendment of the Traffic (Fixed Penalty) Regulations 2011.

- 3.(1) The Traffic (Fixed Penalty) Regulations 2011 are amended in accordance with this regulation.
- (2) In Schedule 1
 - (a) insert the following paragraphs after paragraph 6.—

6A. Travelling on a bicycle or personal Control of Tra light electric transporter other than in Regulation 42A(2) accordance with traffic signs, road lines and markings used to demarcate the cycle lane.

Control of Traffic Regulations 300 Regulation 42A(2)

Regulation 8(2) (50% discount) does not apply.

6B. Driving a motor vehicle on a cycle Control of Traffic lane. Regulation 42B(5)

Control of Traffic Regulations 300 Regulation 42B(5)

Regulation 8(2) (50% discount) does not apply.

6C. Travelling on a bicycle or a personal Control of Traffic light electric transporter on a road, against the flow of traffic, other than on a demarcated contraflow cycle lane.

Regulation 8(2) (50% discount) does not apply.

(b) insert the following paragraphs after paragraph 22.—

- 22A. Parking a motor vehicle on a cycle Traffic (Parking and Waiting) Regulations 2011 Regulation 3(14)
- 22B. Waiting in a motor vehicle on a cycle Traffic

(Parking and Waiting) 200

Regulations 2011 Regulation 3(15)

(c) insert the following paragraph after paragraph 63.—

MOTOR VEHICLES TEST REGULATIONS 1987

64. Using, on a road, a motor vehicle or Motor Vehicles Test Regulations 1987 300 trailer without being in possession of a Regulation 44(1)(a) valid roadworthiness or roadworthiness classic certificate.
