### **Parking Scheme Establishment Order 2011**

In exercise of the powers conferred on me by regulation 8 and all other enabling powers of the Traffic (Parking and Waiting) Regulations 2011 I have established a Parking Scheme within the North District as set out below—

Parking facilities in the North District Zone are divided into five types:

- 1. Free motor cycle parking in which anyone can park free of charge;
- 2. Free car prking in which anyone can park free of charge;
- 3. Pay and Display parking at which cars may be parked on payment of a charge by purchasing a ticket from the ticket machine. The ticket must be displayed at the front windscreen in a manner that it can be read from outside the car;
- 4. Car parking spaces, both on the street and on the ground floor of the Devil's Tower Road multi storey car park, in which those who meet the following requirements may park-
  - (a) live within this Zone and who hold a permit may park. This parking is free of charge;
  - (b) hold an "All Zones Residential Parking Permit for Commercial Vehicles" issued by Gibraltar Car Parks Ltd; or
  - (c) hold an "All Zones Residential Parking Permit for Disabled Badge Holders" issued by Gibraltar Car Parks Ltd;
- 5. Car parking spaces on the street in which those that hold a "Heavy Goods Vehicle Parking Permit" may park.

#### **Residents Only Parking Permit**

A "Residents' Only Parking Permit", which may be obtained from Gibraltar Car Parks Ltd, allows a holder to park in any general "Residents' Permit Holders Only" parking area within the Zone as set out below:

• "North District Residents' Parking Permit"

Holders of this permit may park in any "North District Resident Permit Holders Only" parking area and the Residents' Only Level of the Devil's Tower Road Car Park only and not within "North District Laguna Estate Resident Permit Holders Only", "North District Catalan Bay Resident Permit Holders Only", or "North District Both Worlds Resident Holders Only" parking areas.

• "North District Laguna Estate Residents' Parking Permit"

Holders of this permit may park in any "North District Resident Permit Holders Only", "North District Laguna Estate Resident Permit Holders Only" parking areas and the Residents' Only Level of the Devil's Tower Road Car Park only and not within "North District Catalan Bay Resident Permit Holders Only" or "North District Both Worlds Resident Holders Only" parking areas.

• "North District Catalan Bay Residents' Parking Permit"

Holders of this permit may park in any "North District Resident Permit Holders Only", "North District Catalan Bay Resident Permit Holders Only" parking areas and the Residents' Only Level of the Devil's Tower Road Car Park only and not within "North District Laguna Estate Resident Permit Holders Only" or "North District Both Worlds Resident Holders Only" parking areas.

• "North District Both Worlds Residents' Parking Permit"

Holders of this permit may park in any "North District Resident Permit Holders Only", "North District Both Worlds Resident Permit Holders Only" parking areas and the Residents' Only Level of the Devil's Tower Road Car Park only and not within "North District Catalan Bay Resident Permit Holders Only" or "North District Laguna Estate Resident Holders Only" parking areas.

#### **Heavy Goods Vehicle Parking Permit**

A "Heavy Goods Vehicle Parking Permit", which may be obtained from Gibraltar Car Parks Ltd, allows a holder to park in any "Heavy Goods Vehicle Parking" parking area within the Zone during the signposted hours.
