**Parking Scheme (Glacis Estate Zone) Establishment

*In the exercise of the powers conferred on me by regulation 8 of the Traffic (Parking and Waiting) Regulations 2011, and all other enabling powers, I have established a Parking Scheme within the Glacis Estate Zone as set out below-*

Parking facilities in the Glacis Estate Zone are divided into four types:

1. Free motor cycle parking in which anyone can park free of charge within the spaces demarcated “Free Parking Motor Cycles Only”;
2. Car parking spaces demarcated by signposts with the words “Glacis Estate Resident Permit Holders Only” in which only those who meet the following requirements may park–
  - (a) live within this Zone and who hold a “Residents’ Parking Permit” issued by Gibraltar Car Parks Ltd. This parking is free of charge;
  - (b) hold an “All Zones Residential Parking Permit for Commercial Vehicles” issued by Gibraltar Car Parks Ltd; or
  - (c) hold an “All Zones Residential Parking Permit for Disabled Badge Holders” issued by Gibraltar Car Parks Ltd.
3. Car parking spaces on the ground floor of the Devil’s Tower Road multi storey car park in which only people who meet the following requirements may park–
  - (a) live within this Zone and who hold a “Residents’ Parking Permit”. This parking is free of charge;
  - (b) hold an “All Zones Residential Parking Permit for Commercial Vehicles” issued by Gibraltar Car Parks Ltd; or
  - (c) hold an “All Zones Residential Parking Permit for Disabled Badge Holders” issued by Gibraltar Car Parks Ltd.
4. Car parking spaces demarcated by signposts with the words “Visitors Permit Holders Only” in which only people who do not live within this Zone and who have obtained a “Visitors Permit” from one of the residents of this Zone may park for a maximum duration of one hour between the hours of 8.30am and 9.00pm. This parking is free of charge. Resident Permit Holders may park within these car parking spaces free of charge between the hours of 9.00pm and 8.30am.

A “Residents’ Parking Permit” may be obtained from Gibraltar Car Parks Ltd.
