## TRAFFIC ACT 2005

### TRAFFIC (COMPULSORY BASIC TRAINING) (AMENDMENT) REGULATIONS 2025

In exercise of the powers conferred on it by sections 57 and 101 of the Traffic Act, and all other enabling powers, the Government has made the following Regulations—

#### **Title.**

1. These Regulations may be cited as the Traffic (Compulsory Basic Training) (Amendment) Regulations 2025.

#### **Commencement.**

2. These Regulations shall come into operation on 14<sup>th</sup> April 2025.

#### **Amendment of the Traffic (Compulsory Basic Training) Regulations 2013.**

3.(1) The Traffic (Compulsory Basic Training) Regulations 2013 are amended in accordance with this regulation.

(2) In regulation 3, in the definition of “CBT certificate” for “the competent authority” substitute “an instructor”.

(3) Insert the following regulation after regulation 4-

#### **“Compulsory Basic Training Course Licence.**

4A.(1) In order to undertake Module 3 of the Compulsory Basic Training Course, an eligible person will need to apply to the licensing authority for a Compulsory Basic Training Course licence using the Form set out in Schedule 2.

(2) Every licence issued in pursuance of this regulation shall be in the form set out in Schedule 3 and shall be valid only in respect of Module 3 of the Compulsory Basic Training Course.”.

(4) In regulation 5, subregulation (1), delete paragraph (b).

(5) Insert the following regulation after regulation 5-

**“Authorisations by the licensing authority.**

5A. The licensing authority may authorise instructors for the purposes of these regulations.”.

(6) In regulation 8-

(a) in subregulation (1), delete “to the licensing authority”; and

(b) in subregulation (2), for “licensing authority” substitute “issuing instructor”.

(7) Rename the Schedule, “SCHEDULE 1”.

(8) Insert the following schedules after “Schedule 1”-

**TRAFFIC (COMPULSORY BASIC TRAINING) REGULATIONS 2013**

**Title and Commencement.**

These Regulations may be cited as the Traffic (Compulsory Basic Training) Regulations 2013 and come into operation on the day of publication.

**Application of these Regulations.**

These Regulations apply to all learners of motor cycle, motor tricycle and moped riders in category A.

No person shall be entitled to a learner's licence unless that person successfully completes the CBT.

The minimum age to undertake module 3 as set out in the Schedule is 17 years of age.”.
