## **TRAFFIC ACT 2005**

#### TRAFFIC (PARKING AND WAITING) REGULATIONS 2011

#### PARKING SCHEME (ZONE 1) ESTABLISHMENT (AMENDMENT) ORDER 2022.

In exercise of the powers conferred upon him by regulation 8 of the Traffic (Parking and Waiting) Regulations 2011 and all other enabling powers, the Minister has made the following Order–

#### Title.

1. This Order may be cited as the Parking Scheme (Zone 1) Establishment (Amendment) Order 2022.

#### **Commencement.**

2. This Order comes into operation on the day of publication.

#### Amendment of Parking Scheme (Zone 1) Establishment Order.

3.(1) The Parking Scheme (Zone 1) Establishment Order is amended in accordance with this paragraph.

- (2) Substitute paragraph 3(1) with the following-
  - "1. Residential Parking Car parking spaces demarcated with yellow road markings and signposts with the words
    - (a) "Zone 1 Resident Permit Holders Only" in which a person who holds any of the following permits issued by Gibraltar Carparks Ltd may park–
      - (i) "Zone 1 Residents' Parking Permit";

(ii) "All Zones Residential Parking Permit for Commercial Vehicles"; or

(iii) "All Zones Residential Parking Permit for Disabled Badge Holders";

(b) "Zone 2 Resident Permit Holders Only" in which a person who holds any of the following permits issued by Gibraltar Carparks Ltd may park–

(i) "Zone 2 Residents' Parking Permit";

(ii) "All Zones Residential Parking Permit for Commercial Vehicles"; or

(iii) "All Zones Residential Parking Permit for Disabled Badge Holders"; or

- (c) "Zone 1 or Zone 2 Resident Permit Holders Only" in which a person who holds any of the following permits issued by Gibraltar Carparks Ltd may park–
  - (i) "Zone 1 Residents' Parking Permit";
  - (ii) "Zone 2 Residents' Parking Permit";

(iii) "All Zones Residential Parking Permit for Commercial Vehicles"; or

(iv) "All Zones Residential Parking Permit for Disabled Badge Holders",

This parking is not to be used to park motorcycles.".
