TRANSPORT ACT 1998

TRANSPORT (AMENDMENT NO.4) REGULATIONS 2024

In exercise of the powers conferred on him by section 69 of the Transport Act 1998, and all other enabling powers, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Transport (Amendment No.4) Regulations 2024.

Commencement.

2. These Regulations come into operation on the same day as the Transport (Amendment No.2) Act 2024.

Amendment to the Transport Regulations 2000.

- 3.(1) The Transport Regulations 2000 are amended in accordance with this regulation.
- (2) In regulation 64, insert the following subregulation, after subregulation (5)-
 - "(6) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".
- (3) In regulation 64A-
 - (a) renumber regulation 64A to "64A.(1)";
 - (b) for "advertising;" substitute "advertising."; and
 - (c) insert the following subregulation after the newly renumbered subregulation (1)-
 - "(2) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".
- (4) In regulation 65-
 - (a) renumber regulation 65 to "65.(1)"; and

- (b) insert the following subregulation after the newly renumbered subregulation (1)-
 - "(2) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".

(5) In regulation 66(2), for "commits an offence" substitute "commits an offence and is liable on summary conviction to a fine up to level 3 on the standard scale.".

- (6) In regulation 67, substitute the following for regulation (7)-
 - "(7) A person who contravenes this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".
- (7) In regulation 68, insert the following subregulation after subregulation (2)-
 - "(3) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".

(8) In regulation 69-

- (a) renumber regulation 69 to "69.(1)"; and
- (b) insert the following subregulation after the newly renumbered subregulation (1)-
 - "(2) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".
- (9) In regulation 70-
 - (a) renumber regulation 70 to "70.(1)"; and
 - (b) insert the following subregulation after the newly renumbered subregulation (1)-
 - "(2) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".

(10) In regulation 71, in subregulation (3), for "guilty of an offence" substitute "guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".

(11) In regulation 71A, insert the following subregulation after subregulation (2)-

"(3) A person who fails to comply with the provisions of this regulation is guilty of an offence and liable on summary conviction to a fine up to level 3 on the standard scale.".

(12) In Schedule 3, in Part 1, in the table-

- (a) in the entries 69, 71(1), 71(2), 71A(1) and 71A(2) for "£50" substitute "£300"; and
- (b) in the entries 64A, 65, 66(1), 66(2), 67(1), 67(3), 67(5)(a) and 68(1) for "£100" substitute "£300".
